### **Courses and Birds**

All test levels will be single course with bird field.

Liberated quail and chukar will be used. Other game species may be encountered. All handlers must wear Blaze Orange in accordance with PA Game Commission requirements: "A minimum of 250 square inches, on head, chest and back combined, visible 360 degrees." Handlers in all test levels must use Starter Pistols with blanks ONLY Handlers of Master Level entries must carry an **UNLOADED** shotgun or an "imitation" long-

barreled gun.

All gunning will be done on liberated game and only by Official Guns. All levels are walking.

NO horseback handling will be permitted, and horses will NOT be permitted in the gallery. NO ONE other than gunners, bird planters, and judges permitted at the gunners' tent.
