Handlers in all test levels must use Starter Pistols with blanks ONLY

Handlers of Master Level entries must carry an UNLOADED shotgun or an "imitation" long-barreled gun.

All gunning will be done on liberated game and only by Official Guns.
All levels are walking.

NO horseback handling will be permitted, and horses will NOT be permitted in the gallery.

NO ONE other than gunners, bird planters, and judges permitted at the gunners' tent.

Master/Senior Judges may use ATVs.
